Please find attached Tariff No. 22, which is effective December 1, 2021. This Tariff No. 22 replaces Tariff No. 21 which was effective May 1, 2019.

The Wabasca River Pipeline Tariff No. 8 Rules and Regulations (Revision 2) remain unchanged and have been in effect since August 1, 2021. A copy is available upon request.

Tariff No. 22 and Tariff No. 8 Rules and Regulations will apply to all Crude Petroleum received for shipment through the Wabasca Pipeline system on or after December 1, 2021. The tendering of Crude Petroleum for shipment through the Wabasca Pipeline system on or after November 1, 2021 is an acknowledgment by the Shipper that Tariff No. 22 and Tariff No. 8 Rules and Regulations apply to the transportation of that Crude Petroleum.
